# SPECIAL MEETING MINUTES October 30, 2019

### 1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Paasch at 9:00 a.m. Present were Chair Christopher Paasch, Vice-Chair Court Boice, Commissioner Sue Gold.

Also present: Legal Counsel John Huttl, Director of Operations Julie Schmelzer, Administrative Assistant John Jezuit.

The Pledge was recited by all.

### 2. AMENDMENT/APPROVAL OF THE AGENDA

Huttl -- Add to Executive Session 192.660 (2) (d) To conduct deliberations with persons designated by the governing body to carry on labor negotiations

Motion by Gold, seconded by Boice, to approve agenda as amended. Motion carried unanimously

### 3. PRESENTATIONS

Watermaster Coverage for Curry County – Jake Johnstone, Southwest Regional Manager, Oregon Water Resources Department

Johnstone spoke about redistricting effective January, 2020; the changes necessitating redistricting; the specific details of the redistricting, which are based on drainages; and specifically, the restricting's subsequent impact on Curry County. Johnstone explained the primary source of the water is the Big Butte watershed supplemented by the Rogue River and invited the public to the regional meeting on November 7, 2019 in Medford. Paasch asked how growing communities, like the Willamette Valley, effect the redistricting, expressed concern about Rouge River water temperature, and suggested having someone available for the public to talk to. Boice asked about a document on water vision, stated he is concerned about how the district was put together, stated his concern about citizen travel from Langlois to Roseburg, Medford, and Grants Pass, and suggested an increase in the number of districts. Schmelzer stated people are concerned about loss of water, asked about availability of online services, and asked about a water board for Realtors. Gold suggested setting up local bi-weekly availability for people who need information. Becky Crockett, Planning Director, expressed concern, because water rights are complicated issues, about the impact of these changes on the Planning Department, specifically, the changes will result in an above average potential to significantly stall the Planning Department's ability to provide prompt application processing.
