SECTION TWO	FINDINGS	
 The current Article One, Division Seventeen of the Curry County Code, Ordinance No. 17-01, is entitled "Creating the Office and Position of Curry County Administrator" delegating duties and responsibilities to perform his/ her job functions, and declaring an emergency. Ordinance 17-01 was a departure from historical practices in Curry County; it was not adopted by a unanimous Board; since its adoption, the Board of Commissioners has a new composition that is opposed to the departure from historical county practices reflected in Ordinance 17-01; A majority of the Board of Curry County Board of Commissioners desires to repeal Ordinance No. 17-01 thereby eliminating the position of County Administrator, and return to the historical practices and structure of governance that served Curry County in the past.
