1. *Introductions/Pledge of Allegiance* –**Secretary Neil** opened the meeting at 1:12 pm. Introductions and pledge of allegiance were completed.
2. *Public Comment*— *Gordon Clay spoke on the Suicide Prevention Council and informed the group that the meetings are held on the first Wednesday at 5:00 pm in the Blue Room and their next meeting is February 5th.*
3. *New Business*
 - a. *Criminal Justice Commission: Behavioral/Pre-Trial Grants*—*Ian Davidson, Karen Cann, and Bridget Budbill — Guest Presentations covering Public Safety Task Force, Oregon Pretrial Release Overview, and the Justice Reinvestment Grant and Curry County’s grant awards. Budbill highlighted HB 2238 and the information that the Governor’s office is likely to seek a pretrial reform legislative concept in 2021. Davidson relayed that for the JRI Grant Curry has been granted provisional funding for the first year and then the county will have to reapply for the second year.*
 - b. *Office Against Violence on Women Grant*—*Sevey relayed to the group that the OVW grant that they partner with the District Attorney’s office on and funds multiple positions and programs for Oasis and the DA would be ending October of this year (2020). She is now in the grant writing continuation phase and was looking for approval for the chair of LPSCC to sign a letter of support for the submission of the grant. Sevey explained that since this is a continuation and has been fairly successful that there is the possibility of asking for more money for the community to better serve*

the victims of domestic and sexual violence and cover any additional costs that may arise through salary increases, project costs relating to rental agreements, and benefit increases. The projected timeline of this grant would extend over a period of three years and Sevey is asking for a total of \$600,000.00 for the programs here in Curry County.

MOTION: Ward made a motion for the LPSCC Board Chair to approve and sign the MOU in regards to the OVW grant application. Denney seconded the motion.
