BUDGET COMMITTEE MEETING MINUTES

June 15, 2020

1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Alcorn at 9:12 a.m. Present were Chair Brad Alcorn, Committee members Court Boice, Sue Gold, Christopher Paasch, and Wayne Richards.

Also present: Legal Counsel John Huttli, Julie Schmelzer, Budget Officer, and Administrative Assistant John Jezuit.

Absent: Vice Chair Richard Thode

2. ADOPTION/AMENDMENT OF THE AGENDA

Schmelzer stated the corrected amount on the public legal notice is \$94,972,481.

Huttli explained Agenda Item 4 is to be approved by the Budget Committee, and Agenda Item 5 is to be approved by the Board of Commissioners.

Schmelzer read the resolution. Paasch closed the public hearing. Schmelzer spoke about the amount the average homeowner pays in property taxes that is allocated to the Sheriff's Department compared to the amount allocated to the Commissioner's office.

Motion by Gold, seconded by Boice, to approve all three (3) resolutions as presented. Motion carried unanimously.
