BUDGET COMMITTEE MEETING MINUTES

August 26, 2020

1. CALL TO ORDER

The meeting was called to order by Chair Alcorn at 8:32 a.m. Present were Chair Brad Alcorn, Vice Chair Richard Thode, Committee members Court Boice, Sue Gold, Christopher Paasch, and Wayne Richards.

Also present: Julie Schmelzer, Budget Officer and Administrative Assistant John Jezuit.

Absent: Legal Counsel John Hutt. Joined the meeting at 8:40A

2. ADOPTION/AMENDMENT OF THE AGENDA

No amendments.

Motion by Gold, seconded by Boice, to approve agenda as written. Motion carried unanimously.

4. APPROVE MINUTES

A. Budget Committee Meeting June 15, 2020

5. SHERIFF'S SALARY

Schmelzer explained the reason for today's meeting and recommended a six percent (6%) salary increase. Paasch stated the increase is mandated by law as the Sheriff must be paid more than the highest paid Sheriff Department employee. Boice asked how much is the annual increase in dollars. A discussion ensued. The Budget Committee agreed on a seven percentage (7%) increase for the Sheriff.

Motion by Gold, seconded by Boice, to approve a seven percent (7 %) raise for the Sheriff. Motion carried unanimously.

Julie Swift, Payroll and Personnel Coordinator, asked about the effective date. Schmelzer suggested future Budget Committees review Sheriff Department salaries during the budget process. A discussion followed. The Budget Committee agreed on an effective date of August 1, 2020.

Chair Alcorn adjourned the meeting at 8:48 a.m.






