# BUSINESS MEETING MINUTES December 16, 2020

## 1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Paasch at 9:00 a.m. Present were Chair Christopher Paasch, Vice-Chair Court Boice, Commissioner Sue Gold.

Also present: Legal Counsel John Huttl, Julie Schmelzer and Brad Rueckert Directors of County Operations, and Administrative Assistant John Jezuit.

Schmelzer left meeting at 1:30PM.

## 4. PUBLIC COMMENTS

Mary Rowe spoke about housing and the housing committee. Rebecca Haffley spoke about noise at a construction site in her neighborhood and encouraged the Board to consider a noise ordinance. David Barnes thanked Gold for her service and thanked Schmelzer for her service. Nancy Sue Rose thanked both Gold and Schmelzer for their service, stated she would like to see the Board's letter to the Governor Brown on the website, and praised the Dine to Stay program. Brian Thompson, via Zoom, objected to restricting public access to Floras Lake.

Sheriff Ward presented service awards to three (3) Sheriff's Department personnel: Patrol Deputy Jordan Rhodes for five (5) years of service, Sergeant Stacy Aranda for ten (10) years of service, and Chief Civil Deputy Joan Allen-Steineke for fifteen (15) years of service. Ward spoke highly of Rhodes, Aranda, and Allen-Steineke.

Schmelzer presented the award to Lang and praised Lang's work.

#### 7. DISCUSSION/ACTION ITEMS

A. Discuss Gold Beach Annexation – Commissioner Paasch

Paasch expressed concern about the annexation of the area known as the 'Old Mill Site' on Jerry's Flat Road, specifically it is a cherry stem (not contiguous to City of Gold Beach) annexation, there is a potential loss of revenue for the county, there is an issue with the Urban Growth Boundary, and there is the need to work together. Boice asked about details of cherry stem annexation. Sheriff Ward commented on possible policing issues. Tamie Kaufman, Mayor, City of Gold Beach, spoke about the process starting with the property owners coming to the City of Gold Beach to point out their advantages of being annexed such as lower water costs and improved fire services. Gold asked about sewer services and the impact on environmental issues. Becky Crockett, Planning Director, stated a portion of the property is not within the Urban Growth Boundary line.

B. Honoring Curry County Resident Don Bemis, Courageous Vietnam Combat Soldier – 2 Bronze Stars - Swift Boat Radio Operator - Commissioner Boice

Boice introduced Don Bemis, praised his service work, and read the proclamation. Bemis thanked

the Board and spoke about Wreaths Across America.

B1. Restaurant and Environmental Health - Curry Reduction Of Inspection – Other County Fees – Proposal – Discussion for 2021 – 2022 Possible Changes - Commissioner Boice Boice introduced George Rhodes. Rhodes spoke in detail about the effect of COVID-19 pandemic restrictions on his restaurant operations, suggested changing due date on environmental health fees, and asked the Board to consider a zone for economic development specifically for restaurants. A discussion ensued. Paasch, Boice, Gold, Sherrie Ward, Public Health Administrator, and Rhodes commented on the COVID-19 pandemic's negative impact on Curry County restaurants and possible

- C. Update on Park Improvements Anthony DeRock, Parks Coordinator DeRock showed a seven (7) slide PowerPoint Presentation which addressed details about future improvements at Lobster Creek and Boice County Parks.
- D. Request for Board Approval to Install Non-Conforming "T" Turnaround at Dead End of
   Lakeshore Drive Richard Christensen, Roadmaster
   Christensen explained, based on public input, he wants to back out of this and do more work on it.
   Boice stated he supports the work Christensen has done so far and pointed out drawbacks to the project. Paasch stated the Agenda Item is withdrawn.
- E. Board Approval for Curry County Road Department to Join MORE (Managing Oregon Resources More Efficiently) Statewide Intergovernmental Agreement in Order to Share Resources with Other Oregon Public Agencies Richard Christensen, Roadmaster Christensen explained the agreement between counties.

Motion by Gold, seconded by Boice, to accept agreement. Motion carried unanimously.

F. Board support and Approval to Purchase 34 Acres Curry County Acquired from State Parks Floras Lake Land Swap for New Road Department Storage Facility - Richard Christensen, Roadmaster

Christensen explained advantages and benefits of this new north county location and stated he is looking for Board support. A discussion by Huttl, Boice, Paasch, and Christensen followed. Paasch stated he will be bringing this back in 2021.

G. Replacement Roof on Search and Rescue Building – Chet Brewer, Facilities Director Brewer recommended going with the better warranty.

Motion by Boice, seconded by Gold, to approve. Motion carried unanimously.

- H. Appoint Suicide Awareness and Prevention Council Members Commissioner Boice Huttl noted since the Suicide Awareness and Prevention Council was created by ordinance, a reduction in number of members requires an ordinance amending the original ordinance. Boice suggested moving the reduction of members and the appointment of new members to the December 23, 2020, business meeting.
- I. Curry Site Plan Review Committee Proposal Discussion Commissioner Boice Boice explained the details of the proposal and cited advantages and benefits to the County and the public. A discussion involving Boice, Gold, and Paasch ensued. Paasch recommended Boice schedule this for a workshop, possibly at the end of January, 2021.

L. Hunter Creek Land Sale – Julie Schmelzer, DCO Schmelzer asked the Board for approval to sell parcel at minimum bid.

Motion by Gold, seconded by Boice, to approve the sale of the land for the minimum price. Motion carried unanimously.

M. Retain Architect for CDBG (Community Development Block Grant) Project - Julie Schmelzer, DCO

Schmelzer explained need for an architect. Boice stated this is a waste of money due to lack of parking, location, and downtime to build a new building.

Motion by Gold, seconded by Paasch, to approve architect for the project. Motion carried 2-1 (Gold – Yes; Paasch – Yes; Boice – No)

N. COVID Hazard Pay for Law Enforcement – Julie Schmelzer, DCO Schmelzer explained need for a fee waiver. Paasch stated he believes the hazard pay for law enforcement should be extended.

Motion by Boice, seconded by Gold, to have pay not extend beyond December 31, 2020. Motion carried 2-1. (Boice – Yes; Gold – Yes; Paasch – No)

O. Fee Waiver Request – Silver Cypress Resort – Julie Schmelzer, DCO Schmelzer introduced Crockett who explained the history of the project and recommended waiving the fee.

Motion by Boice, seconded by Gold, to waive the fees. Motion carried unanimously.

P. Housing Committee Members – Julie Schmelzer, DCO Schmelzer spoke about responses, read names of applicants for each position, gave her recommendations, and stated Crockett will fill the staff position. Boice stated he wants to find a spot for Lauren Paulson. A discussion ensued and the Board decided to name Lauren Paulson as first (1st) alternative and Samuel Strom as second (2nd) alternative.

Motion by Gold, seconded by Boice, to accept appointments as previously discussed. Motion carried unanimously.

Q. Update on Departments Who Work Remotely – Brad Rueckert, DCO Rueckert noted there were a handful of departments working remotely, observed most departments are back in the office, commented some departments are still working remotely as it's working well, and stated he thinks managers are being responsible on how they are handling staffing. Paasch stated he doesn't think it is the Commissioner's job to tell Department heads what to do. Gold stated she is fine with that. Boice commented he doesn't know how anyone can be as productive at home; noted he has heard it's best to send people home and work from home; and stated he doesn't think taxpayers will go for that.

## R. Q1 (Quarter 1) Budget Update – Brad Rueckert, DCO

Rueckert stated difficult to give a report as certain items are not yet reflected in the budget at this point in time, summarized the items that are not reflected, and advised he will have more details in January, 2021. Boice stated he wants more details on CARES (Coronavirus Aid, Relief, and Economic Security) funding; specifically which departments are receiving the funds; observed he is really nervous about how we can tie this together by the end of the year; and spoke about OpenGov software. Gold asked about which departments are self-funded and stated OpenGov software will help with payroll. Paasch noted, with OpenGov software, the budget will be updated on a daily basis.
