MINUTES BUSINESS MEETING January 13, 2021

1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Boice at 9:00 a.m. Present were Chair Court Boice, Vice Chair John Herzog, and Commissioner Chris Paasch.

Also present: Legal Counsel John Huttl, Brad Rueckert Director of County Operations, and Administrative Assistant John Jezuit.

The Pledge was recited by all.

2. LINE OF DUTY CASUALTY REPORT

Boice gave the report, spoke about COVID-9 pandemic restrictions, and asked Sherrié Ward, Public Health Administrator, to speak.

3. AMENDMENT/APPROVAL OF THE AGENDA

Motion by Herzog. seconded by Paasch, to approve agenda as amended. Motion carried unanimously.

4. PUBLIC COMMENTS

Kaitlyn Coleman, Event Center Manager, spoke about Fair Board applications and encouraged the Board to appoint citizens to the Fair Board due to vacancies. David Nedervelt read a statement about restaurants opening and asked if the County Fair was on for 2021. David Barnes spoke about the noise ordinance and noted he is opposed to the noise ordinance. Gordon Clay's Public Comment Read After Agenda Item 5A Presentation. Rueckert read Gordon Clay's comment concerning January as National Poverty Awareness Month.

A. Proclamation Honoring Vietnam War Veteran and Curry Resident Paul Hoynacki -Commissioner Boice

Boice praised Paul Hoynacki and read the proclamation. Hoynacki stated he is honored and spoke about his current career. Connie Hunter praised Hoynacki and encouraged the Board to declare 2021 as Year of Support for Curry County's Veterans.

A. Action Item – Discussion - Review and Approve Minutes – December 17 – Emergency Meeting - Commissioner Boice

Boice objected to County Clerk Renee Kolen not being allowed to stay in the Executive Session of December 17, 2020, Emergency Meeting minutes and requested those minutes be amended to reflect his concern.

Motion by Herzog, seconded by Paasch to approve minutes of December 17, 2020 as amended. Motion carried unanimously.

B. Assign Liaison Roles to the Board – Brad Rueckert, DCO, Director of County Operations Boice, Herzog, Huttl, Paasch and Rueckert discussed Boice's liaison recommendations, decided not to have liaisons for elected officials, and made some other changes.

Motion by Paasch, seconded by Herzog, department liaison as stated by DCO. Motion carried unanimously.

Boice, Herzog, Huttl, Paasch and Rueckert discussed committee liaison assignments and decided Commissioner Committee liaison assignments.

Motion by Paasch, seconded Herzog, to approve committee liaisons as read by DCO. Motion carried unanimously.

- C. Langlois Turns 140 Celebration Request for Preliminary Board Support Commissioner Boice Boice spoke about the Celebration and asked the Board for consensus to pursue this. The Board agreed.
- D. Discussion Anti Violence and Freedom to Assemble Future Resolution Proposal? Commissioner Boice

A discussion with Boice, Herzog, and Paasch about violence in the country and state, the Bill of Rights, and the need to get along ensued. The Board reached a consensus to bring this back as a resolution.
