## MINUTES BUSINESS MEETING May 26, 2021

### 1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Boice at 9:00 a.m. Present were Chair Court Boice, Vice Chair John Herzog, and Commissioner Chris Paasch.

Also present: Legal Counsel Anthony Pope, Brad Rueckert Director of County Operations, and Administrative Assistant John Jezuit.

The Pledge was recited by all.

Boice gave the report. Paasch spoke about Memorial Day and showed a Memorial Day tribute video.

A. CAFFA (County Assessment Function Funding Assistance) Grant 2021-22 – Jim Kolen, Assessor

Kolen spoke about amended CAFFA Grant, specifically, the budget committee made some changes which resulted in a decrease in overall expenditure.

Motion by Herzog, seconded by Boice, to approve amended CAFFA Grant application to be signed and dated today. Motion carried unanimously.

B. Curry County Board of Commissioners – Support - Request for Cole Rivers Fish Hatchery Repairs and Modernization - Commissioner Boice

Boice summarized the request. Paasch stated he would like to see the logo changed to Curry County logo. Herzog agrees.

Motion by Herzog, seconded by Paasch, to approve letter of support with logo change and permission to re-read before letter is signed. Motion carried unanimously

C. Curry County – Request of Governor Brown to Send to the Legislature a \$1,000 Bonus for Employees Who Decide to Return to Work or Seek Employment and Remove Themselves from Federal and/or State Unemployment Benefits – Commissioner Boice

Boice spoke about the request. A discussion with Boice, Herzog, Paasch, and Kyle Stevens (Via GoToMeeting), Executive Director, SOWIB (Southwestern Oregon Workforce Investment Board) followed. Neither Herzog nor Paasch supported the request.

- Revisiting his motion regarding Agenda Item 6A, specifically, a discussion with Barnes, Boice, Herzog, and Rose ensued.
- B. Commissioner Paasch spoke about
  - The buildings CCH wants to give back to the County;
  - The Langlois Water District and Sean Stevens, Executive Director;
  - Jackson County Commissioners letter to Governor Brown regarding vaccine mandates; and
  - The recent election, specifically, most positions were uncontested, the number of positions with no candidate running, and the need for citizens to run.
