BUSINESS MEETING MINUTES September 1, 2021

1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Herzog at 9:00 a.m. Present were Chair John Herzog, Vice Chair Chris Paasch, and Commissioner Boice.

Also present: Legal Counsel Anthony Pope and Administrative Assistant John Jezuit.

The Pledge was recited by all.

Boice gave the report and spoke about Afghanistan.

A. Curry County Proclamation Honoring United States Veteran – United States Marine – Soldier – Tim Fortner - Commissioner Boice

Curry County Strategic Plan:

Boice praised Fortner's service, read presidential citation, and read Fortner's statement.

B. Discuss Veterans Affairs and Current Status of the County Veterans Services – Commissioner Paasch and Tony Voudy, VSO (Veterans' Services Officer)

Voudy spoke about Railroad building status, deadlines, processes involved and the VA (Veterans Administration). Adali Pitman, Assistant Veterans' Service Officer, shared updates on how the COVID-19 pandemic is affecting veterans, healthcare IDs, discharge papers, and claims.

Motion by Paasch, seconded by Boice, to approve. Motion carried unanimously.

E. Roadmaster Signature Authority to Sign Roadmaster Letterhead to Oregon Department of Transportation Requesting its \$304,280.82 in State Funds 2021 South County Paving Projects – Richard Christensen

H. Approval to Use ARP Funds for Employee Quarantine Time – Brad Rueckert, Finance Director Rueckert spoke about funds to be used for paying employees out on quarantine. A discussion with Herzog, Paasch, and Rueckert about the amount ensued.

Motion by Paasch, seconded by Herzog, to put into reserve \$100,000 for COVID-19 temporary quarantine. Motion carried 2-0 (Herzog – Yes; Paasch – Yes; Boice - Absent).
