2. AMENDMENT/APPROVAL OF THE AGENDA

Motion by Boice, seconded by Herzog, to approve agenda as written. Motion carried 2-0. (Boice – Yes; Herzog – Yes; Paasch – Absent)

Mary Rowe spoke about County Clerk Renee Kolen's upcoming retirement. Gordon Clay spoke about suicide prevention strategies.

D. Consumption Tax Presentation – Josephine County November Election Plan Ordinance before the Voters - Commissioner Boice

A. Approval of Changes to Internet Service for County Departments – Anthony Pope, County Counsel

Dan Springer, Chief Technology Officer, Coos-Curry Electric Cooperative, spoke about the need for changes, described the proposal, and recommended Option 2. A discussion with Barnes, Boice, Herzog, Pope and Springer about the upgrade ensued.

Motion by Boice, seconded by Herzog, to approve the changes and go with option 2. Motion carried 2-0 (Boice – Yes; Herzog – Yes; Paasch – Absent)

Barnes spoke about the Brookings Turnkey project and asked the Board to submit a letter of opposition as the County does not have resources to support this. A discussion with Barnes, Boice, Herzog, and Phoebe Skinner about medical issues, public safety, and housing ensued.

- E. Adopt Historic Road Department Logo for Road Dept. Staff, Vehicles, and Equipment – Richard Christensen, Roadmaster
Christensen asked the Board to support the historic logo.

Motion by Boice, seconded by Herzog, to support us going back to the historic logo. Motion carried 2-0 (Boice – Yes; Herzog – Yes; Paasch – Absent)2-0

- F. Road Department Awarded \$772K Statewide Transportation Improvements Project (STIP) Grant through the Local Bridge Program Selection Committee for Local Bridge Funding – Richard Christensen, Roadmaster
Christensen spoke about the grant applications.

Motion by Boice, seconded by Herzog to approve item 6F Road Department Statewide Transportation Improvement grant for the bridge. Motion carried 2-0 (Boice – Yes; Herzog – Yes; Paasch – Absent)

M. Bully Prevention, Curry Proclamation – Month of September – at the Request of Citizen Advocate and Dedicated Volunteer, Gordon Clay – Commissioner Boice
Boice spoke about bullying and abuse.

Motion by Herzog, seconded by Boice, to proclaim October bully prevention month. Motion carried 2-0 (Boice – Yes; Herzog – Yes; Paasch – Absent).

7. PUBLIC HEARING

AGENDA ITEM 7 DISCUSSED AFTER AGENDA ITEM 6C

A. Proposed Ordinance Prohibiting Psilocybin Manufacture and Service Centers Outside of City Limits – Anthony Pope, County Counsel
Herzog opened the public hearing, read the Ordinance and asked for public comments. There were no public comments. Herzog closed the public hearing. Boice spoke about Josephine County and the Coos County Sheriff's comments.

Motion by Herzog, seconded Boice, to approve Ordinance 22-02 imposing a prohibition on Psilocybin service centers and product manufacturing in Curry County. Motion carried 2-0 (Boice – Yes; Herzog – Yes; Paasch – Absent).

8. PUBLIC HEARING AT 10:15AM

A. 2021 Community Development Block Grant from the Business Oregon Community Development Block Grant Funds – Commissioner Boice
Herzog opened the public hearing and asked for public comments. There were no public comments nor staff comments. Herzog closed the public hearing.

Herzog opened the public hearing and read the introduction. Crockett gave the staff report which included details of changes and recommended the Board approve and adopt. After the public hearing was closed, a discussion with Boice, Crockett, Herzog, and several citizens about the positive benefits, regulations, STRs (Short Term Rentals), and county oversight followed. The following citizens (*in chronological order*), citing various reasons, spoke against the Board approving the Zoning Ordinance Amendments today, August 17, 2022: Greg Tidey, Pat Reagan, Linda Tarr, Florence Prescott, Tim Palmer, Terry Stone, Zoë Ida Bradbury DeSurra, Clark Assert (*inaudible*), Kimberly Foster, Anonymous, William (*inaudible*), Ann Vileisis, Dave Crook (*inaudible*), Michelle Hanna, Greg Thelen, (*inaudible*) Kessler, John Servaney (*inaudible*), Joy Wolf, Joy Lawrence (*inaudible*), and Debra Goodthron. Greg Thelen, Anne Schmear (*inaudible*), and Representative David Brock Smith, citing various reasons, spoke either in support of or not against the Board approving the Zoning Ordinance Amendments today, August 17, 2022.

Motion by Boice, seconded by Herzog, to close the public hearing and close the record. Motion carried 2-0 (Boice – Yes; Herzog – Yes; Paasch – Absent).

Motion by Boice, seconded by Herzog, to approve or modify the recommendations from the Planning Commission regarding application ZOA 2022.1 amending the Curry County zoning ordinance. Motion carried 2-0 (Boice – Yes; Herzog – Yes; Paasch – Absent).




