BUSINESS MEETING MINUTES

October 5, 2022

1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Herzog at 9:06 a.m. Present were Chair John Herzog, Vice Chair Christopher Paasch, and Commissioner Court Boice.

Also Present: Legal Counsel Anthony Pope and Administrative Assistant John Jezuit

Herzog said a prayer.

The Pledge was recited by all.

Boice spoke about the American Red Cross response to Hurricane Ian.

Motion by Paasch, seconded by Boice, to approve agenda as amended. Motion carried unanimously.

3. PUBLIC COMMENTS

Lynn Coker spoke about Beacon Broadband and Herzog's comments about Beacon Broadband. Connie Hunter spoke about home repair for veterans and commented on Purple Heart Homes work. Dee Ragsdale spoke about and read her letter about the ARP (American Rescue Plan) fund processes.

Christensen presented certificates to both Halcumb and Wolford, each of whom expressed thanks.

Sheriff Ward presented the award. Julie Swift expressed appreciation.

- C. Del Norte County Regional Airport – Advantages to Curry County Citizens - Presentation – Ryan Cooley, Director, BCRAA (Border Coast Regional Airport Authority) and Brookings City Counselor Ed Schreiber - Commissioner Boice

Boice welcomed Cooley and Schreiber. A discussion with Boice, Cooley, Herzog, Paasch, and Schreiber about BCRAA, specifically, the benefits, the impact on tourism, and Contour Airlines followed.

- D. Wildfire Fuels and Erosion Management Plan – Curry County Wildhorse Fire Brigade - William E. Simpson II – Wild Horse Ethologist, National Wildlife Professor-Litigator Michael R. Harris - Commissioner Boice

Boice spoke about past wildfires, wild horses, and introduced (*via GoToMeeting*) William Simpson and Deb Ferns. A discussion with Boice, Ferns, Herzog, Paasch, Tim Palmer, and Simpson about Sir Francis Drake, an early Oregon coast explorer; reducing fuels; daily food consumption of a horse; public and private response to this proposal; the logging industry; and the Federal government ensued.

Herzog opened the public hearing. There were no public comments. Trover spoke about the fees and STRs (Short Term Rentals). A discussion with Boice and Trover about animal control, STR complaint calls, and writing citations followed.

Motion by Paasch, seconded by Boice, to approve. Motion carried unanimously.

Crockett asked for Board approval. A discussion with Boice and Christensen followed.

B. Approval of \$20,654.12 Change Order #1 for the Don Cameron Bridge Pile Cap Repair Project – Richard Christensen, Roadmaster

Christensen showed pictures of the project and stated he had inspected it on October 4, 2022.

Motion by Boice, seconded by Paasch, to approve change order on Cameron Bridge. Motion carried unanimously.

C. Approval of \$23,655.25 Change Order #1 for the 2022 Central County Paving Project on N. Bank Rogue River Road – Richard Christensen, Roadmaster

Christensen summarized the change order

Motion by Paasch, seconded by Boice, to approve. Motion carried unanimously.

D. Roadmaster Signature Authority of \$40,603.57 Cost Increase for New Vector Truck from SWS Equipment – Richard Christensen, Roadmaster

Christensen explained the increase in cost. A discussion with Boice, Christensen, Paasch, and Pope about the contract, delivery date, and the contract's escalation clause ensued.

Motion by Boice, seconded by Herzog, to approve 7D Roadmaster signature authority cost increase for the new Vector truck from SWS. Motion carried 2-1 (Boice – Yes; Herzog – Yes; Paasch – No).

Christensen spoke about the County grant process. A discussion with Barnes, Boice, Christensen, Herzog, and Paasch about grants, specifically, benefits, applying, and managing; the County's SAM (System for Award Management) number; and developing a procedure followed.

Motion by Paasch, seconded by Boice, to approve making a policy to so that every department knows the procedure. Motion carried unanimously.

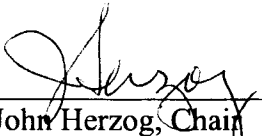
A. **RECOGNIZE INDIGENOUS PEOPLE'S DAY OCTOBER 10, 2022.**
