**Catastrophic Forest Fire Prevention** -- **Lower the risks of a repeating or similar Chetco Bar Fire**  
... Public Awareness and Fire Wise Communities. Additional Burn Tours, fighting for more Timber Salvage, and critical Forest Rehabilitation -- Important Federal, State and Public awareness. Battling unnecessary Road closures and Government overreach. Protecting Citizens, Property and Public Access.

**Public Safety** – giving Law Enforcement every possible tool – Responsibility for improved State-Line Border Security ... All Emergency Management issues and projects.
