Question:

Shall Commissioners Meet Three Times Annually to Discuss Promoting Curry County Interests Regarding Relocating Idaho Borders to Include Curry County?

Summary:

If passed, the petition requires the Curry County Board of Commissioners meet on the second Wednesday of every January, May and September to discuss how to promote the interests of Curry County in any negotiations regarding relocating the state borders of Idaho to include Curry County. Civil penalties are incurred if anyone willfully prohibits, cancels or hinders any of the prescribed meetings of the Board of Commissioners. This is punishable as a Class D Violation with a maximum fine of \$125 and is enforceable by any peace officer.
